Overview

- A "BMFA Members Exhibition Inventory" must be received by USPS mail OR emailed OR hand-delivered by 4 PM, Saturday, April 22, 2023.
- A maximum of six (6) pieces per artist may be displayed.
- Work must not have been previously exhibited at BMFA.
- All media are accepted.
- Original Artwork may be for sale.
- Exhibitors must follow BMFA Members Exhibition Guidelines.
- Hand deliver work Wednesday, April 26, 10 AM 7 PM OR Saturday, April 29, 10 AM - 2 PM.
- NO artwork will be accepted after 2 PM, Saturday, April 29.
- BMFA retains 30% commission on all sales.
- Artist is responsible for hand-delivery and pick-up of artworks on the specified days and times.

GENERAL GUIDELINES:

- Exhibiting BMFA members must be current on payment of dues and 18 years or older. Non-members may join and pay for BMFA prior to Registration deadline.
- BMFA Members Art Exhibition Inventory must be received by USPS mail OR emailed OR hand-delivered by 4 PM, Saturday, April 22, 2023.
- Members may exhibit a maximum of six (6) artworks. At least one (1) artwork must be original and for sale. Copy artwork or artwork done in a BMFA class may be exhibited but will not be for sale.
- Members may exhibit four (4) artworks at no charge: maximum of 36 x 48" or 1728 sq. in. (without frame). One (1) or two (2) additional artworks may be displayed for a submission fee of \$10 each.
- Submission fees are NON-REFUNDABLE.
- Work must not have been previously exhibited at BMFA.
- Labels for each artwork will be prepared by the BMFA using the information provided by the artist: Artist's Name, Title of Artwork, Medium, Dimensions, Year Created, Price, and a 225 word or less Artist's Biography as a Word document to post with your art and on social media. Information will be pulled verbatim, so check the accuracy of all information as well as correct spelling.
- Once artwork details for labels are submitted, they may not be changed, i.e., changing the Price or Title of Artwork or substituting another artwork.
- A charge of \$2 per day per piece will be charged for storage of artwork not picked up Wednesday, May 31, 10 AM-8 PM OR Saturday, June 3, 10 AM-2 PM. Artwork not retrieved by July 1 at 4 PM will become the property of the BMFA.
- All artworks must be ready for hanging/display according to the details below in "Artwork Guidelines."
- The BMFA reserves the right to refuse to display any artwork for any reason.
- Artwork must remain on display for the duration of the Exhibition.
- The artist grants the BMFA permission to publish their images for BMFA publicity in both printed and electronic form. Credit to the artist will be included.

ARTWORK GUIDELINES:

- Artwork must be suitable for public exhibition. The BMFA reserves the right to refuse for display any artwork for any reason.
- CANVASES: must be either framed OR gallery wrapped with **edges painted** and no visible staples.

- HANGING: All 2-dimensional works must have a hanging wire, securely attached, using screw eyes or D-rings, ¼ of the height below the top of the frame.
- WIRE: The wire cannot be visible above the frame while hanging. No single strand metal wire or nylon filament may be used.

• TWO-DIMENSIONAL SIZE and SUBMISSION FEE:

1-4 artworks, maximum of 36 x 48" or 1728 sq. in. (without frame): no submission fee 5 artworks, maximum of 36 x 48" or 1728 sq. in. (without frame): \$10 submission fee 6 artworks, maximum of 36 x 48" or 1728 sq. in. (without frame): \$20 submission fee

- 2 artworks larger than 36 x 48" or 1728 sq. in. (without frame) and 1 artwork maximum of 36 x 48" or 1728 sq. in. (without frame): \$10 submission fee
- 2 artworks larger than 36 x 48" or 1728 sq. in. (without frame) and 2 artworks maximum of 36 x 48" or 1728 sq. in. (without frame): \$20 submission fee
- 1 artwork larger than 36 x 48" or 1728 sq. in. (without frame) and 4 artworks maximum of 36 x 48" or 1728 sq. in. (without frame): \$20 submission fee

3 artworks larger than 36 x 48" or 1728 sq. in. (without frame): \$20 submission fee

• THREE-DIMENSIONAL SIZE AND SUBMISSION FEE:

1-3 artworks: maximum of 4 x 5 x 6' or 120 cu. ft.: no submission fee Three-dimensional works must be stable and manageable by one (1) person OR installed by artist.

- Hand-pulled artist's prints must be signed and numbered in series
- All works on paper, matted, and framed under glass, Plexiglas, or acrylic.
- All work must be clean and dust free.
- All work must have been created since 2018 and not have previously been exhibited at the BMFA.

SALES:

- At least one (1) artwork must be original and for sale. Copy artwork or artwork done in a BMFA class may be exhibited but will not be for sale.
- The artist receives 70% of the sale price and the BMFA retains a 30% commission.

- Payment to the artist will be remitted the month following the sale.
- Prices are set by the artist. The BMFA does not negotiate sales prices and does not provide advice on pricing.
- Artwork must remain on display for the duration of the Exhibition.
- The BMFA is not responsible for the shipping of any artwork.

PROHIBITED:

- Flimsy, plastic, damaged, overly ostentatious, or tabletop frames.
- Saw-tooth or standalone D-ring hangers (MUST HAVE WIRE!).
- Hot glue or any type of visible glue.
- Command Strips or anything adhesive.
- Tape of any kind cannot be visible nor used for structural support.
- Warped panels.
- Bowed stretcher bars.
- Unmitered wooden frame corners.
- Artwork must be suitable for public exhibition. The BMFA reserves the right to refuse for display any artwork for any reason.
